



## **2018 Hingham Maritime Center: Scholarship Policy**

Hingham Maritime Center in Hingham, MA is a community boating center dedicated to providing safe, affordable access to Hingham Harbor through the sports of sailing and rowing. As part of our mission, we make a limited amount of youth scholarships available each year.

### **The upper income thresholds and scholarship amounts are as follows:**

Household income **\$65,000** and under/year are eligible for:

- **75% fee reduction** per program per child.

Household incomes between **\$65,000-\$85,000**/year are eligible for:

- **50% fee reduction** per program/ per child

*Please note that the total scholarship amount is limited to \$750 per family/per year.*

The above are guidelines to help you determine if you should apply. If you are ineligible for a scholarship due to the above criteria but have special or mitigating circumstances that prevent you from being able to afford youth sailing or rowing fees, please get in touch to discuss your circumstances (see below for details).

### **Application Process:**

- The application process is confidential and only the Executive Director and a small sub-committee of HMC board members will know of your application and any details provided.
- Interested individuals are encouraged fill out the following form, scan and send it to contact the Executive Director prior to class bookings and/or typically no later than April 15th.
- If eligible, you will be placed in the class with the pro-rated balance applied to your account.
- If you have already booked the class and you are making a retrospective application, a refund for the scholarship amount will be issued to you if you qualify.
- Applicants may be asked, on a confidential basis, to provide additional supporting documentation (such as 1040s).
